ORDER CONCERNING BRIEFS

On April 23, 2019, the Commission conducted an evidentiary hearing in this case. The transcript of the hearing is due on May 7, 2019. Previously, on April 16, 2019, the Staff of the Missouri Public Service Commission ("Staff") filed a *List of Issues, Order of Witnesses, and Order of Cross Examination*. The Commission will issue its Order setting a briefing schedule and directing the parties therein to address the issues which Staff has identified.

THE COMMISSION ORDERS THAT:

1. Union Electric Company, d/b/a Ameren Missouri shall, and all other parties may file principal briefs no later than ten (10) days after the transcript of the evidentiary hearing is filed.
2. The parties may, but need not file reply briefs. Any reply brief shall be filed no later than twenty (20) days after the transcript of the evidentiary hearing is filed.

3. All principal briefs shall address the issues set out in Staff's *List of Issues, Order of Witnesses, and Order of Cross Examination*. The parties' briefs may address any other issues which are deemed material.

4. All principal briefs shall identify the statutes, regulations and/or tariffs which are material to the Commission's jurisdiction and provide the rule(s) of decision with respect to the issues.

5. Where the resolution of any issue requires mathematical computation(s), the brief shall set out the computation completely and in exact detail and cite to any supporting evidence of record, i.e., "show your work."
