On March 27, 2019, the Commission issued its *Order Directing Notice, Establishing Intervention Deadline, and Directing Filing of Staff Recommendation*. The Staff of the Missouri Public Service Commission ("Staff") was directed to file its recommendation no later than April 24, 2019. On April 24, 2019, Staff filed a *Motion for Extension of Time* ("Motion"). In its *Motion*, Staff states that on April 18, 2019, Union Electric Company d/b/a Ameren Missouri ("Company") filed a substitute tariff sheet with the Commission. Staff states that it needs two more days to complete its analysis and that the Company does not object to the extension. The Commission will grant the *Motion*.

THE COMMISSION ORDERS THAT:

1. The *Motion for Extension of Time* of the Staff of the Missouri Public Service Commission ("Staff") is granted.
2. The Staff shall file its recommendation no later than April 26, 2019.
3. This order shall be effective when issued.
