On December 3, 2018, Union Electric Company d/b/a Ameren Missouri submitted to the Commission revised tariff sheets to implement a general rate increase of \$4,264,318, or 3.3%. The Commission requested the parties submit proposed locations for local public hearings. After considering the parties' positions concerning local public hearings, the Commission has determined it will hold four local public hearings.

# THE COMMISSION ORDERS THAT:

1. The Commission's Public Policy and Outreach Department shall make an informal presentation and conduct a question-and-answer session for the public at the beginning of each local public hearing.

2. Union Electric Company d/b/a Ameren Missouri, the Staff of the Commission, and the Office of the Public Counsel shall make a representative available to address substantive issues during the question-and-answer sessions. Any other party may choose to have a representative present.

3. No later than ten days before the local public hearings Union Electric Company d/b/a Ameren Missouri shall provide notice of the hearings to each of its customers.

4. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the media and the General Assembly representing customers in Union Electric Company d/b/a Ameren Missouri's service area.
