## ORDER SETTING EXPEDITED TIME FOR RESPONSE

On April 19, 2019, the Office of the Public Counsel filed a Motion to Open the Evidentiary Record and Admit Exhibits, which requests that the Commission admit two late-filed exhibits. The Commission established a shortened deadline for responses to the motion in order to accommodate the briefing schedule. The Commission also extended the time for filing the initial briefs, at Public Counsel's request, to allow time for responses and a ruling on the admissibility of Public Counsel's exhibits.

On April 25, 2019, The Empire District Electric Company filed a response and objection to Public Counsel's request to admit additional exhibits. Empire stated, however, that if the Commission admitted Public Counsel's exhibits, it requested portions of the transcript from Commission File No. EO-2018-0092 and a portion of the Southwest Power Pool (SPP) open access transmission tariff (OATT) be admitted as well.

The Commission will expedite the time for responses to Empire's request as set out below.

### THE COMMISSION ORDERS THAT:

1. Any responses or objections to the admission of portions of the transcript from File No. EO-2018-0092 (pages 187, ln. 6 – 188, ln. 15; 356, ln. 20 -359, ln. 1; 689, ln. 11 – 690, ln. 9; 702, ln. 5 – 702, ln. 19; and, 725, ln. 19 –726, ln. 21) and the Southwest

Power Pool - Open Access Transmission Tariff, Sixth Revised Volume No. 1 –  
Attachment AE Integrated Marketplace – Section 2.2 shall be filed no later than **1:00 p.m.**,  
**Friday, April 26, 2019.**
