On April 26, 2019, Union Electric Company d/b/a Ameren Missouri filed tariff sheets (Tariff Tracking No. YE-2019-0192) to implement its electric vehicle charging corridor program. The tariff sheets have a May 26, 2019, effective date.

The Commission will direct its Staff to file a recommendation and set a time for other responses to the tariff.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a recommendation regarding Tariff Tracking No. YE-2019-0192 no later than May 7, 2019.
2. Any other responses or objections to Tariff Tracking No. YE-2019-0192 shall be filed no later than May 7, 2019.
3. Any responses to the Staff recommendation or other responses or objections shall be filed no later than May 13, 2019.
4. This order is effective when issued.


