**ORDER CANCELLING EVIDENTIARY HEARING**

The Commission set this matter for an evidentiary hearing on May 1<sup>st</sup> and 2<sup>nd</sup> of 2019. Applicant filed a motion to continue the evidentiary hearing, and in support of its motion states that Carl Mills will be unable to attend the currently scheduled hearing because of medical issues. Applicant states that the Commission's Staff, the Office of the Public Counsel, and the Intervenors consent to continuing the hearing.

Applicant asks to reschedule the evidentiary hearing to a mutually agreeable date in June. This regulatory judge's limited availability requires that the parties choose two days in the third week of June (17-21), 2019.

**THE COMMISSION ORDERS THAT:**

1. The evidentiary hearing scheduled for May 1<sup>st</sup> and 2<sup>nd</sup> of 2019, is cancelled.
2. The parties shall jointly submit new dates for the evidentiary hearing no later than May 3, 2019.

3. This order shall be effective when issued.
