ORDER SETTING PREHEARING CONFERENCE

On February 20, 2019, Missouri-American Water Company (“MAWC”) filed a petition requesting that the Commission authorize it to change its Infrastructure System Replacement Surcharge. Staff filed its recommendation on April 22, 2019. MAWC filed its response disagreeing with Staff’s recommendation on April 26, 2019. MAWC requests a hearing on the matter and states its preference for the week of May 20, 2019.

In order to discuss a procedural schedule, the Commission will set a prehearing conference.

THE COMMISSION ORDERS THAT:

1. The parties shall appear at a prehearing conference to be held on May 2, 2019, at 10:00 a.m.
2. The prehearing conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act.
