**ORDER EXTENDING DEADLINE**

Effective Date: April 30, 2019

On February 14, 2019, the Commission issued its *Order Approving Stipulation and Agreement and Granting Certificates of Convenience and Necessity* (“Order”). The Order allowed Confluence Rivers Utility Operating Company, Inc. (“Company”) to acquire two sewer systems operated by M.P.B. Inc. – Villa Ridge and Lake Virginia. The Order also required the Company to “file adoption notice tariff sheets for each tariff currently in effect for the regulated Selling Companies, as 30-day filings, within ten (10) days of closing on the respective assets.”

On April 29, 2019, the Company filed a *Motion for Extension of Time to File Tariff Sheets Related to the M.P.B., Inc. Assets I* (“Motion”). The Motion states that per the Order, the Company is acquiring both the Villa Ridge and Lake Virginia systems from M.P.B., Inc.<sup>1</sup> The Motion explains that the Company closed on the Villa Ridge system assets on April 19, 2019, but has not yet closed on the Lake Virginia system because of a pending easement issue. The Motion explains, further, that the uncertainty as to the Lake Virginia system closing has also created an uncertainty with respect to the

appropriate direction for the Villa Ridge tariff filing. The Company, accordingly, requests an extension of the deadline for either filing an adoption notice of the current tariff sheets or otherwise for filing tariff sheets associated with the Villa Ridge assets to May 13, 2019. The Commission will grant the requested extension.

**THE COMMISSION ORDERS THAT:**

1. The *Motion for Extension of Time to File Tariff Sheets Related to the M.P.B., Inc. of Confluence Rivers Utility Operating Company, Inc.* (“Company”) is sustained.
2. The Company shall file adoption notice tariff sheets for each tariff currently in effect for M.P.B., Inc. for the Villa Ridge assets<sup>2</sup> or shall otherwise file tariff sheets for the Villa Ridge assets no later than May 13, 2019.
3. This order shall be effective when issued.
