ORDER APPROVING COMPLIANCE TARIFF

Issue Date: July 27, 2011

Effective Date: July 31, 2011

On July 13, 2011, the Missouri Public Service Commission issued its report and order rejecting the tariff filed by Union Electric Company, d/b/a Ameren Missouri, and directing Ameren Missouri to file a revised tariff to effectuate the terms of the report and order. Ameren Missouri filed a revised tariff on July 18 in compliance with that report and order. That tariff bore an effective date of August 17, but along with its tariff, Ameren Missouri filed a motion for expedited treatment, asking the Commission to approve the tariff sheets to be effective July 31, which is the date to which the Commission had suspended Ameren Missouri's initial rate increase tariff filing.

Upon receiving Ameren Missouri's motion for expedited approval of its tariff, the Commission issued an order on July 19, directing its Staff to file a recommendation regarding Ameren Missouri's tariff by July 25. That order also directed any other party wishing to file a recommendation regarding Ameren Missouri's tariff to do so no later than July 25.

On July 25, the Commission's Staff filed its recommendation regarding Ameren Missouri's compliance tariff filing and motion for expedited treatment. Staff concludes that the tariff complies with the Commission's report and order, and recommends the Commission approve the compliance tariff to be effective on July 31. No other party filed a recommendation and no party has filed a response to Staff's recommendation.

The Commission has reviewed the proposed tariff and Staff's recommendation. The Commission concludes that the submitted compliance tariff is consistent with the Commission's report and order. Expedited approval of the revised tariff is appropriate because the Commission has found that the rates resulting from its report and order are just and reasonable and Ameren Missouri should not be required to wait an inordinate amount of time to implement those rates. Thus, for good cause shown pursuant to Section 393.140(11), RSMo 2000, The Commission will approve Ameren Missouri's tariff to become effective for service rendered on and after July 31.

THE COMMISSION ORDERS THAT:

1. The proposed electric service tariff submitted under Tariff No. YE-2012-0021 by Union Electric Company, d/b/a Ameren Missouri, is approved effective on and after July 31, 2011. The specific tariff sheets approved are:
