On April 24, 2019, the Commission issued its *Order Granting Certificate of Convenience and Necessity and Waiver* (“Order”). The Order required Spire Missouri, Inc. (“Company”) to update Tariff Sheet No. 20.1 to incorporate the area described in the Certificate of Convenience and Necessity issued per the same Order. On April 30, 2019, the Company filed a Tariff Revision under Tracking No. YG-2019-0197 (“Tariff Sheet”). The effective date of the Tariff Sheet is May 30, 2019. The Commission will order the Staff of the Missouri Public Service Commission to file a recommendation.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Missouri Public Service Commission shall file a recommendation on the tariff submitted by Spire Missouri, Inc. under Tracking No. YG-2019-0197<sup>1</sup> no later than May 13, 2019.
2. This order shall be effective when issued.
