ORDER DIRECTING RESPONSE

In the Office of the Public Counsel's response to the March 25, 2019 Staff Report (as corrected on March 29, 2019), two issues were raised regarding Staff's calculations. The Commission assumes that Staff is filing a response to those issues, however, in an abundance of caution, the Commission will direct Staff to provide a response to OPC's issues.

Specifically, the Commission directs Staff to explain:

- 1) With regard to Public Counsel's first issue, why service renewals are included in blanket work orders?
- 2) With regard to Public Counsel's second issue, whether the plant removed in the transfer work orders in question includes plastic? If so, why an adjustment was not made? Also, what percentage of the removed plant was plastic?

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a response no later than 5:00 p.m., May 1, 2019, which includes the explanations set out above.
2. This order is effective when issued.
