**ORDER REJECTING PROPOSED PROCEDURAL SCHEDULE AND
DENYING REQUEST TO CANCEL PREHEARING CONFERENCE**

Effective Date: May 1, 2019

Filed on February 20, 2019, Missouri-American Water Company's Infrastructure System Replacement Surcharge case has an operation of law date of June 20, 2019. MAWC requested a hearing on the matter and stated a preference for the week of May 20, 2019.

On May 1, the parties jointly filed a proposed schedule, and a request to cancel the prehearing conference.

Orders of the Commission become effective 30 days after served unless otherwise provided.¹ At a minimum, 10 days must be given. Thus with an operation of law date being June 20, and the Commission holding its Agenda meetings on Wednesdays, the Commission will need to vote on its decision no later than the Agenda scheduled for June 5. That necessitates the Commission's case discussion to occur the week before at the Agenda scheduled for May 29. In order for the case discussion to occur on time, the post hearing briefs would need to be submitted no later than May 24.

As the parties' joint proposed schedule conflicts with the needs of the Commission in deciding the case, the Commission will reject it. As the proposed schedule is rejected, so too is the accompanying request to cancel the prehearing conference.

THE COMMISSION ORDERS THAT:

1. The parties' joint proposed schedule is rejected.
2. The prehearing conference will be held on May 2, 2019, at 10:00 a.m., and the parties' request to cancel it is denied.
3. This order shall be effective when issued.
