Section 536.200.2, RSMo 2000 requires the Commission to review the fiscal note that it attached to its 2017 revision of Rule 4 CSR 240-10.075 at the end of the first full fiscal year following the implementation of the rule. As part of that review, the Commission's Staff filed a motion on May 3, 2019, asking the Commission to invite interested stakeholders to offer comments about whether the estimated costs to comply with the rules set out in the fiscal notes have proved to be accurate. The Commission will do so.

1. Comments regarding the actual cost of compliance shall be filed with the Commission by June 6, 2019.
2. The Commission's Data Center shall provide a copy of this order to all persons who filed comments regarding the rule.
