# **ORDER APPROVING TARIFF**

Issue Date: December 15, 2023 Effective Date: December 28, 2023

On December 4, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence) filed a tariff to comply with the Commission's November 1, 2023 Order Approving Transfer of Assets and Granting Certificate of Convenience and Necessity (Order). Contemporaneously therewith, Confluence filed a Motion for Expedited Treatment. The tariff bears an effective date of January 3, 2024, but Confluence asks for expedited treatment so that the tariff will become effective on the closing date of the transaction, which is no later than December 28, 2023.

The Commission's Staff filed a Recommendation on December 8, 2023, followed by an Amended Recommendation later that day. The Amended Recommendation stated that the Commission should approve the tariff on an expedited basis. No other responses were received.

The Commission finds that the tariff complies with the Commission's November 1, 2023 order. The Commission will approve the tariff. The Commission further finds that Confluence has demonstrated good cause for the tariff to become effective on December 28, 2023.

## THE COMMISSION ORDERS THAT:

- 1. The Motion for Expedited Treatment is granted.
- 2. The tariff filed by Confluence on December 4, 2023, and assigned Tracking

No. JS-2024-0088, is approved to become effective on December 28, 2023.

3. This order shall be effective December 28, 2023.
