On May 19, 2023,¹ Spire Missouri Inc. d/b/a Spire filed an application requesting a variance from the Resale Provision of its Tariff Rules and Regulations. The Staff of the Commission (Staff) was directed to file a recommendation no later than July 6, later extended to October 13 and December 13.

On December 13, Staff filed a status report indicating there are still outstanding data requests, and requested a further extension to March 13, 2024, to file its recommendation. The Commission finds this request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff shall submit its recommendation or an appropriate alternate filing no later than March 13, 2024.
2. This order shall be effective when issued.
