ORDER SETTING DISCOVERY CONFERENCE

On May 19, 2023,¹ Spire Missouri Inc. d/b/a Spire filed an application requesting a variance from the Resale Provision of its Tariff Rules and Regulations. The Staff of the Commission (Staff) was directed to file a recommendation no later than July 6, later extended to October 13 and December 13.

On December 13, Staff filed a request for a discovery conference due to its need for additional information, specifically from the City of Kansas City. The Commission finds the request reasonable and will grant it.²

THE COMMISSION ORDERS THAT:

1. A discovery conference shall be held at 2:00 p.m. on Tuesday, January 9, 2024, by WebEx only. Login details will be electronically mailed to the parties.
2. This order shall be effective when issued.
