MOTION TO INTERVENE OF MARK EDWARD KREBS

I, Mark Edward Krebs, have been a residential customer of Ameren Missouri for nearly three decades. Furthermore, I am recently retired, on a fixed income (SSI) and am visually handicapped. I strongly contend that the most likely results of this unfolding travesty will be serious additional economic harm (at best) to me and consumers like me. Additionally, the premature retirement of Ameren's Rush Island plant in conjunction with a "transition" to relatively unreliable renewable generation creates significant risks to grid stability during extreme weather (e.g., "polar vortex") events.

I am also the principal of a consumer-focused consulting start-up, the "Gas Analytics & Advisory Services" (GAAS).
