On December 14, 2023, IM Telecom, LLC d/b/a Infiniti Mobile requested designation as an Eligible Telecommunications Carrier (ETC) to be eligible to provide Lifeline service. Notice of the application shall be sent to all incumbent and competitive local exchange carriers certificated to provide service in Missouri. The Commission will also set a deadline for intervention requests and direct the filing of a recommendation by the Staff of the Commission (Staff).

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send notice of this application to all incumbent and competitive local exchange carriers certified to provide service in Missouri.
2. Any request to intervene shall be filed with the Commission no later than January 4, 2024. Such applications shall be filed with:
