On April 17, 2019, the Commission issued its *Order Granting Certificate of Convenience and Necessity and Waiver* (“Order”). The Order was effective on April 27, 2019. The Order required United Services, Inc. (“Company”) to submit a complete tariff for sewer service, as a thirty day filing, within ten days of the effective date of the Order. On May 6, 2019, the Company filed tariff sheets under Tracking No. YS-2019-0203 (“Tariff Sheets”). The effective date of the Tariff Sheets is June 5, 2019. The Commission will direct Staff to file a recommendation on the Tariff Sheets and will establish a time for any other party to respond to Staff’s recommendation.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Missouri Public Service Commission shall file a recommendation on the tariff sheets submitted by United Services, Inc., under Tracking No. YS-2019-0203 no later than May 17, 2019.
2. Any party wishing to respond to Staff’s recommendation shall do so no later than May 22, 2019.
3. This order shall be effective when issued.
