ORDER GRANTING APPLICATION TO INTERVENE

On December 1, 2023, Union Electric Company d/b/a Ameren Missouri filed a tariff to adjust the rate of its Energy Efficiency Investment Charge. The Commission directed notice and set a deadline for applications to intervene. On December 6, 2023, the Missouri Industrial Energy Consumers (MIEC) filed a timely application to intervene. More than ten days have passed since the application was filed and no one has responded.

After considering the unopposed application to intervene, the Commission finds that MIEC has interests which are different from that of the general public and allowing it to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the application to intervene.

THE COMMISSION ORDERS THAT:

1. The application to intervene filed by MIEC is granted.
2. This order is effective when issued.
