The Commission set this matter for an evidentiary hearing on May 1-2, 2019. On April 26, 2019, Mr. Mills filed an unopposed motion to continue the evidentiary hearing. The Commission granted the motion and ordered the parties to submit new dates for the evidentiary hearing for the third week of June. On May 3, 2019, the parties submitted proposed evidentiary hearing dates of June 19-20, 2019. However, the Commission's current schedule makes those dates unavailable. The Commission will reschedule the evidentiary hearing for June 24-25, 2019. Any party with opposition to those evidentiary hearing dates may file a motion to that effect.

THE COMMISSION ORDERS THAT:

1. The evidentiary hearing is scheduled for June 24, 2019, beginning at 9:00 a.m. and June 25, 2019 beginning at 10:00 a.m. The hearing will be held in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. The hearing will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. Any person requiring additional accommodations to
