
Pulsar360, Inc. filed notice on April 22, 2019, advising the Commission that it has changed the name under which it does business in Missouri to Pulsar360, Corp. The Commission directed its Staff to file a recommendation regarding that notice by May 7. On that date, Staff filed a motion asking the Commission to direct Pulsar360, Inc. to file additional information. Staff also seeks additional time to file its recommendation. The Commission will grant Staff's requests.

THE COMMISSION ORDERS THAT:

1. No later than May 24, 2019, Pulsar360, Inc. shall file notice of the date its new name will take effect, documentation that the new name is registered with the Missouri Secretary of State, and a statement that it has reviewed and updated its contact information in the Commission's Electronic Filing and Information System (EFIS).
2. The Staff of the Missouri Public Service Commission shall file either a recommendation regarding the notice filed by Pulsar360, Inc., or an update regarding the status of this case, no later than June 10, 2019.

3. This order shall be effective when issued.
