On April 15, 2019, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company filed the above-referenced pleadings. The Missouri Division of Energy applied to intervene on April 23, 2019. No party objected to the intervention request. Thus, the Commission will take it up unopposed.

Commission Rule 4 CSR 240-2.075(4) allows the Commission to grant intervention to a person who has an interest different from that of the general public and which may be adversely affected by a final order arising from the case, or if granting intervention would serve the public interest. Upon review of the unopposed application, the Commission finds that the applicant meets the standard in Commission Rule 4 CSR 240-2.075(4). Therefore, the Commission will grant the application.

1. The application to intervene filed by The Missouri Division of Energy is granted.
2. This order shall be effective when issued.


