On August 8, 2023, the Commission ordered Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (together, “Evergy”) to make an on-the-record presentation to the Commission in November 2023, January 2024, and April 2024.
