On April 17, 2019, the Commission issued its *Order Granting Certificate of Convenience and Necessity and Waiver* ("Order"). The Order was effective on April 27, 2019. The Order approved a monthly flat rate for sewer service of \$43.84 applicable to commercial customers and to residential customers in Countryside subdivision. On May 9, 2019, the Staff of the Missouri Public Service Commission ("Staff") filed a *Request for Amended Order* ("Request"). The *Request* asked the Commission to issue an amended order correcting the rate from \$43.84 to \$42.84.

On May 7, 2019, the Commission issued an *Order Directing Filing* to Staff to file a recommendation on the tariff sheets submitted by United Services, Inc., no later than May 17, 2019. The Commission will issue an order that any objection or other response from the Office of Public Counsel or any other party to Staff's *Request* shall also be filed no later than May 17, 2019.

- Any objection from the Office of Public Counsel or any other party to Staff's Request for Amended Order shall be filed no later than May 17, 2019.
