## ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On May 7, 2019, the Staff of the Missouri Public Service Commission filed a motion requesting that Advanced Integrated Technologies, Inc.'s ("Advanced Integrated Technologies") certificate of service authority and accompanying tariff to provide intrastate interexchange and competitive local exchange telecommunication service in the State of Missouri be cancelled at the company's request. The Commission granted Advanced Integrated Technologies a certificate of service authority to provide competitive local exchange telecommunication service in the State of Missouri in File Number CA-2004-0125. The Commission granted Advanced Integrated Technologies a certificate of service authority to provide intrastate interexchange telecommunication service in the State of Missouri in File Number XA-2004-0126.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no

request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.

1. Anyone wishing to respond to Staff's Motion or request a hearing shall do so by filing a pleading no later than May 20, 2019, with:
