ORDER DIRECTING STAFF TO FILE A RECOMMENDATION

On May 10, 2019, Missouri Network Alliance, LLC d/b/a Bluebird Network submitted a cover letter and list of rates. The letter explains that Bluebird offers telecommunications services to health care providers in predominantly rural areas of Missouri under the federal Rural Health Care Telecommunications Program. It cites a Federal Communications Commission regulation – 47 C.F.R. 54.607(b) – that requires Bluebird to submit its interstate rates for such telecommunications services to the applicable state commission for approval. As required by the federal regulation, Bluebird has submitted a confidential justification purporting to demonstrate that each rate is appropriate.

The Commission will direct its Staff to file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file a recommendation regarding Missouri Network Alliance, LLC d/b/a Bluebird Network's request no later than June 10, 2019.

2. This order shall be effective when issued.


