### ORDER DIRECTING FILING

On February 14, 2019, the Commission issued its *Order Approving Stipulation and Agreement and Granting Certificates of Convenience and Necessity* ("Order") approving the Application of Confluence Rivers Utility Operating Company, Inc., (the "Company") to acquire certain water and sewer assets and the existing certificates of convenience and necessity ("CCN") held by the selling companies and granting new CCNs for the areas served by the selling companies that had none. As a part of the Order, the Commission ordered the Company to "file adoption notice tariff sheets for each tariff currently in effect for the regulated Sellers, as 30-day filings, within ten (10) days of closing on the respective assets." On May 13, 2019, the Company filed *New Tariffs* ("tariff sheets").<sup>2</sup> Each of the tariff sheets bears an issue date of May 13, 2019, and a proposed effective date of June 12, 2019. The Commission will order the Staff of the Missouri Public Service Commission ("Staff") to file a recommendation on the tariff sheets. The Commission will also allow any party who wishes, to file an objection or response to the tariff sheets or to Staff's recommendation.

- 1. The Staff of the Missouri Public Service Commission shall file a recommendation on the tariff sheets<sup>3</sup> no later than May 23, 2019.
- 2. Any party wishing to object or otherwise respond to the tariff sheets or to Staff's recommendation shall do so no later than May 25, 2019.
  - 3. This order will be effective when issued.
