ORDER GRANTING APPLICATION TO INTERVENE

On November 29, 2023, Spire Missouri Inc. d/b/a Spire filed an application for approval of a Carbon Offset Initiative and a request for waiver from the Commission's 60-day notice rule. Along with its application Spire filed tariff sheets to implement the program. The tariff sheets bear a December 29, 2023 effective date.

The Commission directed notice and set a deadline of December 11, 2023, for applications to intervene and December 15, 2023 for responses to applications to intervene. On December 6, 2023, the Missouri Industrial Energy Consumers (MIEC) filed a timely application to intervene. No responses to the application to intervene were filed.

After considering the unopposed application to intervene, the Commission finds that MIEC has interests which are different from that of the general public and allowing it to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the application to intervene.

THE COMMISSION ORDERS THAT:

1. The application to intervene of MIEC is granted.
2. This order is effective when issued.
