**MOTION FOR EXTENSION**

**COMES NOW** Summit Natural Gas of Missouri, Inc. (“SNGMO”), and respectfully submits this *Motion for Extension*, requesting additional time to respond to the Staff of the Missouri Public Service Commission’s (“Staff”) Recommendation, and in support states as follows:

1.       On December 12, 2023, the Staff filed its *Staff Recommendation Regarding Summit’s 2021-2022 Actual Cost Adjustment Filing*. Thereafter, the Commission issued its *Order Directing Filing* wherein it directed SNGMO to respond to Staff’s Recommendation by January 12, 2024.

2.       After review of the Staff Recommendation and discussion, SNGMO requires additional time to further evaluate and develop its response to Staff’s Recommendation. Given the upcoming holidays, several key Company members will be unavailable, making the development and formulation of a response by January 12 extremely challenging. Accordingly, SNGMO requests that the Commission permit it until January 31, 2024, to respond to the Staff Recommendation.

3.       Counsel for SNGMO has discussed this motion with counsel for the Staff and Staff counsel has indicated he has no objection to this motion.

**WHEREFORE**, SNGMO requests that the Commission extend the deadline for its response to the Staff Recommendation until January 31, 2024.
