ORDER GRANTING EXTENSION OF TIME

On December 12, 2023, the Staff of the Commission (Staff) filed its recommendation regarding Summit Natural Gas of Missouri, Inc.'s (SNGMO's) Actual Cost Adjustment filing. Staff requested that the Commission order SNGMO to respond within 30 days to Staff's concerns, comments, and recommendations included in the Staff Recommendation and Memorandum.

The Commission directed SNGMO to respond no later than January 12, 2024. On December 20, 2023, SNGMO filed a request for an extension of time due to the unavailability of key employees during the response time. The request of SNGMO indicates that Staff does not object to the requested extension.

The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. No later than January 31, 2024, SNGMO shall file a response to Staff's concerns, comments, and recommendations.
2. This order shall be effective when issued.
