NOTICE THAT TARIFF WILL BE ALLOWED TO GO INTO EFFECT

Issue Date: May 16, 2019

On April 26, 2019, Confluence Rivers Utility Operating Company, Inc. (“Company”) filed proposed tariff sheets YS-2019-0193. These tariff sheets were filed in response to the Commission’s February 14, 2019, *Order Approving Stipulation and Agreement and Granting Certificates of Convenience and Necessity* (“Order”). This Order required the Company to adopt the existing sewer and water tariffs currently in effect for Mill Creek Sewers, Inc. The Mill Creek Sewers, Inc. tariff sheets are proposed to become effective on May 26, 2019.

Staff filed a *Recommendation to Approve Tariff Sheets* (“Recommendation”) on May 6, 2019. The *Recommendation* stated that the tariffs comply with the Commission’s Order and recommended that the Commission approve them. The Commission received no other responses to the tariff filing or Staff’s *Recommendation*.

Given Staff's recommendation and no opposition to the tariff's taking effect, the Commission will allow the Tariff sheets in Tariff No. YS-2019-0193² to take effect by operation of law on May 26, 2019.
