ORDER ESTABLISHING TIME FOR STAFF TO FILE REPORT

On April 15, 2019, The Empire District Electric Company filed its 2018 Renewable Energy Standard (RES) Compliance Report and 2019 RES Compliance Plan. Commission Rule 4 CSR 240-20.100(8)(D) allows the Commission's Staff up to 45 days from the date of filing to review that filing and to file its report regarding that review. Forty-five days from the April 15 filing date is May 30. Also on April 15, the Commission granted Empire's request to be allowed until July 1, 2019, to file the Retail Rate Impact portions of its Compliance Report and Plan. Forty-five days from July 1 is August 14.

On May 6, Staff filed a pleading asking that it be allowed until May 30 to file its report regarding the main part of Empire's Report and Plan, and until August 14 to respond to the Retail Rate Impact portions of that Report and Plan. No party has responded to Staff's request. The Commission will establish the filing dates requested by Staff.

THE COMMISSION ORDERS THAT:

1. Staff shall file its report regarding The Empire District Electric Company's partial 2018 RES Compliance Report and 2019 RES Compliance Plan no later than May 30, 2019.

2. Staff shall file its report regarding the Retail Rate Impact portions of The Empire District Electric Company's 2018 RES Compliance Report and 2019 RES Compliance Plan no later than August 14, 2019.

3. This order shall be effective when issued.
