#### ORDER APPROVING QUARTERLY COST ADJUSTMENT TARIFF

Issue Date: May 20, 2019 Effective Date: June 1, 2019

On April 15, 2019, KCP&L Greater Missouri Operations Company (GMO) filed the pending tariff sheet, Tariff No. JH-2019-0186, setting forth the quarterly cost adjustment (QCA) for the first quarter of calendar year 2019. On May 7, Staff recommended the tariff sheet be approved or allowed to go into effect by operation of law.

In its verified recommendation, Staff states that it has reviewed the tariff sheet and the mathematical calculations GMO provided and is of the opinion that GMO has calculated the QCA for the first quarter of 2019 in accordance with the appropriate tariff provisions<sup>1</sup>. Staff recommends the Commission approve the proposed tariff sheet or allow it to become effective by operation of law. Commission Rule 4 CSR 240-2.080(13) states that parties have ten days to respond to pleadings unless otherwise ordered. Ten days have elapsed since Staff's recommendation. No party has objected or filed any response to the request.

As the application is unopposed, and so that this tariff may go into effect expeditiously on the requested effective date, the Commission will make this order effective in eleven days.
