ORDER CANCELING CERTIFICATE

Issue Date: May 21, 2019 Effective Date: May 31, 2019

This order cancels the private pay telephone certificate of Interstate Telecommunications, Inc.

On May 6, 2019, the Staff of the Missouri Public Service Commission filed a motion requesting Interstate's certificate to provide private pay telephone service in the State of Missouri be canceled.

In Case Number TA-95-214, the Commission granted Interstate a certificate of service authority to provide private pay telephone service in the State of Missouri via customer-owned coin-operated telephone equipment.

Staff's motion states that the company requested cancellation of its certificate of service authority. Staff recommends that the Commission cancel Interstate's certificate of service authority as the company is no longer providing service in Missouri.

On May 10, 2019, the Commission issued an Order Establishing Time to Respond to Motion allowing anyone to file a response or request a hearing to do so no later than May 20, 2019. No responses were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo 2016 which states, in part, "[a]ny certificate

or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Interstate's request and Staff's motion, the Commission finds that the private payphone certificate granted to Interstate Telecommunications, Inc., shall be canceled.

THE COMMISSION ORDERS THAT:

- 1. The private payphone certificate granted to Interstate Telecommunications, Inc., in Case Number TA-95-214, is canceled.
 - 2. This order shall become effective on May 31, 2019.
 - 3. This case may be closed on June 1, 2019.
