ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION AND TIME FOR RESPONSES

On May 17, 2019, Missouri-American Water Company ("MAWC") filed tariff sheets to reflect changes based upon Commission approval of a Certificate of Convenience and Necessity allowing MAWC to purchase and operate a sewer system in the Timber Springs Estates subdivision in Clinton County, Missouri. The tariff sheets bear an effective date of June 16, 2019.

MAWC also filed a *Motion for Expedited Treatment* on May 17, 2019, requesting that the tariff take effect with less than thirty days notice. In support of its motion, MAWC states that the subject of the Commission approved transactions closed on April 17, 2019, and MAWC owns the system. In addition, the tariff revisions clarify the rates, rules, and regulations that will apply to the subject customers going forward. Therefore, MAWC is asking for the proposed tariff sheets (YS-2019-0209) to be effective as soon as the Commission has an opportunity to address the matter.

The Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation on an expedited schedule. The Commission will also establish a

deadline for any other entity to file a response to the tariff sheets or Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. No later than May 24, 2019, the Staff of the Missouri Public Service Commission shall file a recommendation with regard to the tariff sheets filed by Missouri-American Water Company.

2. Any other entity wanting to comment on the tariff sheets or Staff's recommendation shall do so no later than May 29, 2019.

3. This order shall be effective when issued.
