**ORDER APPROVING EVERGY’S MODIFIED
TECHNICAL RESOURCE MANUAL**

Issue Date: December 20, 2023

Effective Date: January 1, 2024

On December 7, 2023, Evergy Missouri Metro and Evergy Missouri West (collectively “Evergy”) filed a request for approval of modifications of its Technical Resource Manual (TRM) to incorporate Evaluation, Measurement, and Verification (EM&V) results from program year 3 of MEEIA Cycle 3. Evergy states that the modifications were provided to Commission Staff (Staff) and that Staff reviewed the modifications and expressed no concerns. The Implementation Team and Evergy’s contractors also reviewed the proposed modifications. The modifications will not require any adjustment of the MEEIA portfolio’s goals. Evergy Missouri requests that the modified TRM be allowed to become effective on January 1, 2024. The Commission set a deadline for any other responses or recommendations regarding the TRM, but received none.

The Commission concludes that the modified TRM should be approved to be effective January 1, 2024. So that the modified TRM becomes effective January 1, 2024, the Commission finds it reasonable to make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. Evergy’s modified TRM, filed December 7, 2023, is approved.

2. This order shall be effective on January 1, 2024.
