ORDER SUSPENDING PROCEDURAL SCHEDULE AND CANCELLING EVIDENTIARY HEARING

On March 8, 2019, the Commission issued its *Order Adopting Procedural Schedule* ("Procedural Schedule"). The *Procedural Schedule* set the case for an evidentiary hearing, to commence on June 3, 2019, and to continue on June 4, 2019, if necessary. On May 21, 2019, Missouri-American Water Company filed a *Motion to Refer Complaint to Mediation*, stating therein that the parties had agreed to engage in mediation, requesting that the evidentiary hearing be cancelled, and requesting that the case be scheduled for mediation. The Commission will suspend the *Procedural Schedule* and cancel the evidentiary hearing scheduled to begin on June 3, 2019. The Commission will later enter further orders with respect to mediation or as otherwise shall appear appropriate.

THE COMMISSION ORDERS THAT:

1. The Order Adopting Procedural Schedule is suspended.

- 2. The evidentiary hearing scheduled to commence on June 3, 2019, is cancelled. All other actions on the case shall cease and all time limitations shall be tolled pending further orders.¹
