ORDER CANCELING REGISTRATION

Issue Date: May 22, 2019 Effective Date: June 1, 2019

On May 6, 2019, Staff filed a motion requesting the Commission cancel Toshiba America Information Systems, Inc.'s ("Toshiba") registration to provide Interconnected Voice over Internet Protocol service ("IVoIP") in the state of Missouri. The Commission granted Toshiba its IVoIP registration in the state of Missouri in File No. DA-2012-0355.

Staff states in its motion that the company notified the Commission that it no longer wished to be registered as an IVoIP provider in Missouri.

On May 7, 2019, the Commission issued an Order Establishing Time to Respond allowing parties to file an objection or request a hearing no later than May 17, 2019. No objections or requests for a hearing were filed.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on Toshiba's request and Staff's motion, the Commission finds that the IVoIP registration granted to Toshiba America Information Systems, Inc., shall be canceled.
