## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: May 22, 2019 Effective Date: June 1, 2019

On May 7, 2019, the Staff of the Missouri Public Service Commission filed a motion requesting Advanced Integrated Technologies, Inc.'s ("Advanced Integrated Technologies") certificate of service authority and accompanying tariff to provide competitive local exchange and intrastate interexchange telecommunication service in the State of Missouri be cancelled.

In File Number CA-2004-0125, the Commission granted Advanced Integrated Technologies a certificate of service authority to provide competitive local exchange telecommunication service in the state of Missouri. In File Number XA-2004-0126, the Commission granted Advanced Integrated Technologies a certificate of service authority to provide intrastate interexchange telecommunication service in the state of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Advanced Integrated Technologies contacted Staff stating Advanced Integrated Technologies wished to relinquish all of its wireline authority and requested the Commission cancel Advanced Integrated Technologies' certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange and competitive local exchange telecommunications services, and the company's accompanying tariff.

On May 10, 2019, the Commission issued an Order Establishing Time to Respond allowing parties until May 20, 2019, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Advanced Integrated Technologies, Inc., shall be canceled.

#### THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide interexchange and competitive local exchange telecommunications services granted to Advanced Integrated Technologies, Inc., in File Number CA-2004-0125 and XA-2004-0126, is canceled.

2. Advanced Integrated Technologies, Inc.'s tariff, P.S.C. Mo No. 1, is canceled.

3. This order shall become effective on June 1, 2019.
