ORDER DIRECTING AMEREN TO RESPOND TO STAFF RECOMMENDATION AND SETTING TIME FOR OTHER RESPONSES

On December 12, 2023, The Staff of the Commission (Staff) filed its recommendation about Union Electric Company d/b/a Ameren Missouri's actual cost adjustment (ACA) filing. Staff's recommendation proposed adjustments to Ameren Missouri's 2021-2022 ACA account balances and also made non-monetary recommendations. Staff has asked that the Commission order Ameren Missouri to respond to those recommendations within 30 days. The Commission will order Ameren Missouri to respond to Staff's ACA recommendation and memorandum.

THE COMMISSION ORDERS THAT:

1. No later than January 17, 2024, Ameren Missouri shall file a response to Staff's recommendation.
2. Any other responses to Staff's recommendation or Ameren Missouri's ACA filing shall be filed no later than January 17, 2024.

3. This order is effective when issued.
