At the evidentiary hearing a witness for the Missouri Department of Natural Resources stated that she had drafted a noncompliant well agreement for Mr. Blevins that was under internal review prior to being executed. The Commission will direct its Staff to provide more information concerning the status of that noncompliant well agreement and when it is expected to be executed. If the noncompliant well agreement is available, Staff will inform the Commission of its availability.

THE COMMISSION ORDERS THAT:

1. Staff will inform the Commission of the status of the noncompliant well agreement and its availability no later than January 10, 2024.
2. This order is effective when issued.
