**NOTICE THAT TARIFF WILL BE ALLOWED TO GO INTO EFFECT**

Issue Date: May 28, 2019

On April 30, 2019, Spire Missouri, Inc. (“Company”) filed a Tariff Revision under Tracking No. YG-2019-0197 (“Tariff Sheet”). Its effective date is May 30, 2019. On May 1, 2019, the Commission ordered the Staff of the Missouri Public Service Commission (“Staff”) to file a recommendation on the Tariff Sheet. On May 9, 2019, Staff filed *Staff’s Compliance Tariff Recommendation* (“Recommendation”). Staff recommended approval of the Tariff Revision. On May 9, 2019, the Commission issued its order allowing any party wishing to do so to file any objection or other response to the *Recommendation* no later than May 16, 2019. The Commission has received no responses to the tariff filing or to Staff’s *Recommendation*.

Given Staff’s recommendation and no opposition to the Tariff Revision, the Commission will allow the Company’s Tariff revision under Tracking No. YG-2019-0197 to go into effect on May 30, 2019.


