

ORDER GRANTING INTERVENTION

On November 5, 2001, the United States Executive Agencies (USEA) filed its untimely application to intervene, stating that Whiteman Air Force Base is a significant consumer of power generated by UtiliCorp United, Inc., and that USEA has a substantial interest herein that cannot be adequately represented by any other party. No party objected to USEA's application and Intervenor Sedalia Industrial Energy Users Association filed its pleading supporting USEA's application. Therefore, the application will be granted.

IT IS THEREFORE ORDERED:

1. That the United States Executive Agencies are granted intervention in this case in accordance with 4 CSR 240-2.075(4).
