# **ORDER ESTABLISHING PROCEDURAL SCHEDULE**

Issue Date: December 21, 2023

Effective Date: December 21, 2023

On November 15, 2023, the Commission ordered its Staff (Staff) to communicate with the parties and file a proposed procedural schedule. Staff responded by asking that the Regulatory Law Judge hold a procedural conference to establish a procedural schedule. The Commission held a procedural conference on December 5, 2023, and the parties agreed to a procedural schedule.

During the procedural conference there was discussion concerning the Commission's Rule 20 CSR 4240-2.070(15)(E), that requires the Commission to hold the evidentiary hearing within 30 miles of the location where service was rendered. Upon examination, that Commission rule only applies to small formal complaints. None of the complaints in this file qualify as small formal complaints. Accordingly, the Commission will hold the evidentiary hearing at its Jefferson City office. However, for the convenience of

the complainants, the Commission will allow some complainants to participate in the evidentiary hearing via WebEx telephone and videoconferencing software.

The Commission consolidated several complaints under this complaint because they are identical in the violations they allege, involve the same questions of law, involve Evergy Missouri West as the respondent, and concern the same geographic region of Evergy Missouri West's service area. Commission Rule 20 CSR 4240-2.040(5), concerning practice before the Commission by non-attorneys, states that a natural person may represent himself or herself, but practice is strictly limited to the individual representing himself or herself on his or her own behalf, but not any other person or entity. While all of these complaints are essentially identical, no single complainant represents any other complainant.

The Commission will establish a procedural schedule as discussed at the December 5, 2023, procedural conference.

### THE COMMISSION ORDERS THAT:

1. The following procedural schedule is established:

3. The evidentiary hearing is scheduled for January 23-25, 2024, beginning at 9:00 a.m. The hearing will be held Governor Office Building, Room 310, 200 Madison Street, Jefferson City, Missouri, and will begin each day at 9:00 a.m. or as ordered by the Regulatory Law Judge at the hearing. This building meets accessibility standards required by the Americans with Disabilities Act. 4. Due to the number of complainants, participation by telephone and videoconference will be permitted via WebEx video conference software. WebEx meeting information will be provided to interested complainants at the January 18, 2024, WebEx prehearing conference. Complainant's interested in appearing via WebEx should email the Regulatory Law Judge prior to the prehearing conference.
