AMEREN MISSOURI'S RESPONSE TO PUBLIC COUNSEL'S MOTION FOR THE COMMISSION TO ORDER AMEREN MISSOURI AND AUTHORIZE PUBLIC COUNSEL TO PUBLICLY DISCLOSE INFORMATION

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") and, pursuant to 20 CSR 4240-2.080(13) and the Commission's December 14, 2023, *Order Directing Response*, hereby responds to Public Counsel's ("OPC") above-referenced motion, as follows:

- 1. OPC's motion alleges that the Company did not comply with the designation requirements of 20 CSR 4240-2.135 (the "Confidentiality Rule") and specifically, 20 CSR 4240-2.135(2)(B), with respect to information marked as confidential in the direct testimony and schedules of Company witness Steven Whitworth, filed on November 21, 2023. As relief, OPC requests Commission permission to in effect sanction the Company for its alleged non-compliance by allowing OPC to disregard the confidentiality of this information and publicly disclose the same. Alternatively, OPC seeks an order requiring the Company to fully comply with the Confidentiality Rule's designation requirements within 10 days of a Commission order requiring that the Company do so.
- 2. As discussed below, the Company generally agrees that its attempt to comply with the designation requirements of the Confidentiality Rule fell short of its compliance obligations, and that it is appropriate for the Commission to require that the Company fully comply within 10 days of a Commission order imposing such requirement. However, no statute or rule, including

the Confidentiality Rule, provides authority for a party – including OPC – to publicly disclose information for which a claim of confidentiality is made, nor is there any such statute or rule that would authorize the Commission to disregard the confidentiality claim of a party as a sanction for that party's initial non-compliance with the Confidentiality Rule in full.

- 3. The confidential information in question appears on pages 11 and 18-19 of Mr. Whitworth's direct testimony, and in Schedules SCW-D1 through SCW-D19 and SCW-D21 to his testimony. With two exceptions (Schedules SCW-D1 and SCW-D21), the information in question consists of reports, work papers, or other documentation relating to the work of external attorneys and thus is confidential (without obtaining a protective order) under the provisions of 20 CSR 4240-2.135(2)(A)5. Specifically, all such material and documents were prepared by the law firm of Hunton & Williams, which acted as attorneys for the Company and other utilities who engaged Hunton & Williams services via an industry association formed by such utilities known as the Utility Air Regulatory Group ("UARG"). Through UARG, Hunton & Williams provided advice and work product to the utilities, including Ameren Missouri, to aid such utilities in their compliance with applicable air statutes and regulations, including the federal Clean Air Act and regulations issued thereunder.
- 4. OPC also noted that certain information is redacted in Schedules SCW-D5, SCW-D6, SCW-D9, SCW-D10, SCW-D13, SCW-D14, SCW-D15, and SCW-D16 and that is true, and for good reason. The redacted information in those schedules is redacted pursuant to the attached Order of the federal district court in *United States of America v. Ameren Missouri*, Civil Action No. 4:11-cv-00077-RWS, US. Dist. Ct. for the E.D. of Missouri. While the District Court had

determined that much of the information in those Schedules was no longer privileged (on the grounds that privilege had been waived given one of the defenses the Company had raised in the litigation), no such waiver was found by the District Court as to the redacted information, which has never been disclosed in any forum. And while the District Court required production of the unredacted portions of those Schedules because of the waiver of the privilege as to the unredacted portions, the unredacted portions of the documents at all times remained confidential, just as they are confidential under the Commission's Rule, as discussed above.

5. The Company apologizes for not properly designating this information (and for its mis-designation due to a misunderstanding between the undersigned counsel and Company administrative staff assisting with putting together the Company's direct case filing in this docket). The Company has reviewed its procedures to ensure that in the future it applies the proper designations on pages of testimony where confidential information appears and on confidential schedules, as required by 20 CSR 4240-2.135(2)(B).

6. In summary:

- a. The Company requests that the Commission deny OPC's request that it simply be allowed to make the confidential information public;
- b. Order the Company, within 10 days of the issuance of such an order, to designate the above-referenced pages and schedules in the Mr. Whitworth's direct testimony as "Confidential" and specify as part of those designations the application of 20 CSR 4240-2.135(2)(A)5, and to refile Mr. Whitworth's confidential version of testimony containing the proper designations; and
- c. Refile the public version of Mr. Whitworth's direct testimony and include therein Schedules SCW-D1 and SCW-D21 which, while marked confidential

at the time of their preparation, are not privileged and do not fall within any of the categories of 20 CSR 4240-2.135(2)(A) and thus should be public.

WHEREFORE, the Company hereby responds to OPC's motion and requests the relief set forth in paragraph 6 hereof.

In accordance with and for the reasons stated on the record during today's hearing,

IT IS HEREBY ORDERED that the United States' Motion to Compel Production of Communications between Defendant Ameren and Third Party Utility Industry Associations #[369] is **GRANTED** in part and **DENIED** in part.

As stated on the record, Ameren shall produce each of the 53 documents that were submitted to the Court for *in camera* review. The contents of these documents shall be produced to the extent that they contain relevant information that is responsive to the United States' motion to compel. Information regarding UARG's budget, for example, may be redacted because it is irrelevant. Likewise, information that does not respond to the United States' request for communications relating to the operation, interpretation, implementation, or enforcement of EPA's NSR and PSD regulations may be redacted.

I note that the United States has withdrawn its request for any Category 1 information, which the parties describe as information relating to UARG's rulemaking and related litigation efforts. As I stated on the record, I have also found that the materials containing counsel's mental impressions about UARG's rulemaking and related litigation efforts constitutes protected

work product. As a result, Category 1 information and the related work product may be redacted from the documents. I have provided a document-by-document review of the Category 1-related information that Ameren may redact from each of the documents. Ameren shall have until March 16, 2015 to produce the redacted documents to the United States in compliance with the terms of this Order.
