**NOTICE TO THE COMMISSION**

**COME NOW**, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“Evergy Missouri Metro”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy Missouri West”) (collectively, the “Company”) and for their *Notice to the Commission* (“Notice”), state as follows:

1. On November 16, 2023, the Missouri Public Service Commission (“Commission”) issued its *Order Approving Stipulation and Agreement Extending Evergy’s MEEIA Cycle 3 An Additional Year* (“Order”).

2. Per the *Unanimous Stipulation and Agreement* (“Agreement”) approved by the Order, the Staff (“Staff”) for the Commission, the Office of the Public Counsel (“OPC”), and the Company agreed to file a procedural schedule for the Company’s MEEIA Cycle 4 by January 1, 2024.<sup>1</sup>

3. This is to inform the Commission that Staff, OPC, and the Company will file the required procedural schedule or a status report by January 16, 2024.
