ORDER DIRECTING NOTICE, ESTABLISHING TIME TO INTERVENE, AND DIRECTING STAFF RECOMMENDATION

On May 22, 2019, 188 North Summit, LLC, filed an application asking the Commission to cancel its certificates of convenience and necessity to provide water and sewer service granted in File Nos. SM-2018-0017 and WM-2018-0018. 188 North Summit, LLC, also requests “decertification” so that it is clear that the company is not under the jurisdiction of the Commission, a waiver of the sixty-day notice rule (4 CSR 240-4.020(2)(B)), and, if necessary, cancelation of its tariffs.

The Commission will give notice of the application, direct the company to provide notice of the application to each of its tenants receiving water or sewer service, and set a date for intervention of proper parties. The Commission will also direct its Staff to file a recommendation regarding the application.

THE COMMISSION ORDERS THAT:

1. The Data Center of the Missouri Public Service Commission shall serve a copy of this order upon the county commission of Callaway County, Missouri.

2. The Public Policy and Outreach Department of the Missouri Public Service Commission shall send a copy of this order to members of the General Assembly and to the media that serve the service area of 188 North Summit, LLC.

3. No later than June 5, 2019, 118 North Summit, LLC, shall provide notice of this application by mailing or hand delivering a copy of this order to each of its tenants receiving water or sewer service.

4. Any person or entity wishing to intervene in this matter shall file an application to do so no later than June 14, 2019.

5. Staff shall file a recommendation regarding 188 North Summit, LLC's application, or a status report stating when it expects to file its recommendation, no later than June 28, 2019.

6. Any responses to Staff's recommendation shall be filed no later than July 8, 2019.

7. This order shall be effective when issued.
