ORDER APPROVING TARIFF

Issue Date: May 31, 2019

Effective Date: June 16, 2019

On April 17, 2019, the Commission issued an order granting Missouri-American Water Company (“MAWC”) a certificate of convenience and necessity to provide sewer services to the Timber Springs Estates subdivision, and authorized the Company to file new tariff sheets in compliance with that order. On May 17, 2019, MAWC filed tariff sheets to reflect changes based upon Commission approval of a Certificate of Convenience and Necessity. The tariff sheets bear an effective date of June 16, 2019, but MAWC filed a motion for expedited treatment asking the Commission to approve the compliance tariffs to take effect with less than thirty days’ notice.

The Commission ordered its Staff to file a recommendation by May 24, 2019, and that any party wishing to respond to the tariff sheets or Staff’s recommendation do so no later than May 29, 2019. The Commission’s Staff timely filed its recommendation advising that the tariffs comply with the Commission’s order granting the certificate. Staff advises approval of the tariffs and expedited treatment. No other party has filed an objection or response.

The tariff would need to be submitted at the Commission's weekly agenda to receive expedited treatment. The next agenda is June 5, 2019. Missouri courts have determined that the Commission must allow ten days after the issuance of an order for the order to become effective or it is presumptively unreasonable. Therefore, no expedited treatment is possible. The Commission concludes that the submitted tariffs should be approved to go into effect on June 16, 2019.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheets submitted under Substitute Tariff No. YS-2019-0209, as substituted, by Missouri-American Water Company are approved, effective on and after June 16, 2019. The specific tariff sheets approved are:

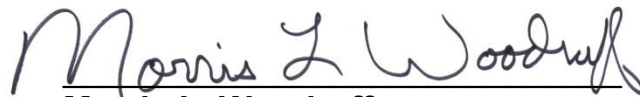
