On May 10, 2019, Confluence Rivers Utility Operating Company, Inc. ("Company") filed proposed tariff sheets YW-2019-0204. On May 10, 2019, the Company filed a substitute tariff for YW-2019-0204. These tariff sheets were filed in response to the Commission's February 14, 2019, *Order Approving Stipulation and Agreement and Granting Certificates of Convenience and* Necessity ("Order"). This *Order* required the Company to adopt the sewer and water tariffs currently in effect for Smithview H2O Company. The Smithview H2O Company tariff sheets bear an issue date of May 9, 2019, and a proposed effective date of June 8, 2019.

Staff filed a *Recommendation to Approve Tariff Sheets* ("Recommendation") on May 20, 2019. The *Recommendation* stated that the tariffs comply with the Commission's Order and recommended that the Commission approve them. The Commission received no other responses to the tariff filing or Staff's *Recommendation*.
